



# Grand PiK

## TERMS AND CONDITIONS OF THE INTERNATIONAL ARTISTIC RADIO FORMS COMPETITION AND RADIO ART WORKSHOPS "GRAND PIK 2015"

1. The body organizing the competition and workshops is the Polish Radio – the Regional Radio Station in Bydgoszcz "Polskie Radio Pomorza I Kujaw" S.A. in Bydgoszcz, at ul. Gdańska 48-50, 85-006, registered in the District Court in Bydgoszcz, XIII Commercial Department KRS 0000183992, Tax Identification No 554-03-16-293, share capital: 703.900,00 PLN, paid-in capital: 703.900,00 PLN, management: Michał Jagodziński – president of the board.
2. Date and location of the competition and workshops: 07.09.2015 – 11.09.2015, The Romantic Palace in Turzno, ul. Toruńska 1.
3. **Part-taking in the Radio Art Workshops is not subject to entering the Competition.** The Workshops participant is obliged to send in the entry application form by 30.06.2015.
4. Productions of either Polish and foreign authors recorded in any language can be entered to the competition under conditions of point 9c.
5. The owner of the financial copyrights to the production should declare the production free from legal defects and that it does not breach personal rights of third parties.
6. Upon entering the competition the owner of the production financial copyrights, excluding radio plays, grants the organising body along with the right to employ the neighbouring copyrights, a free six-month license to use the awarded productions in full or in part in the country and abroad. The remaining productions' financial copyrights owners: free license for the period of the competition: 30.06.2015 – 10.09.2015.

The license will include the following means of exploitation:

- a) Recording in any technique
  - b) Multiplying on any medium/carrier
  - c) Public presentations
  - d) Radio, television and internet broadcasting
  - e) Re-emissions
  - f) Public availability of the productions in a way that they are accessible to anyone in a preferred place and time
  - g) Entering to the computer memory and multimedia networks
  - h) Publishing purposes.
7. Only productions created after 01.01.2014 (1st January 2014) can be entered to the competition excluding those entered to the last year's edition.
  8. Only productions whose authors (or their representatives) take part in the workshops will be qualified for the competition.
  9. Rules of the competition:
    - a) Only creative productions of distinct characters and artistic forms of the content they convey i.e. radio plays, reportages, neoreportages, documentaries, radio impressions, unclassified productions can be entered to the competition.
    - b) Information on the productions should be sent in by 30.06.2015 exclusively by filling in the form that is available at [www.grandpik.pl](http://www.grandpik.pl)
    - c) Productions on compact discs (in audio CD formats) should be delivered in 6 (six) copies along with the entry application form, tax purposes declaration and a script of the production written in English by 30.06.2015 (determined by postal stamp date)
    - d) Every financial copyrights owner can enter a maximum of two works which combined running time does not exceed 60 minutes
    - e) The Organiser reserves the right to pre-selection of the entered productions. No more than 25 qualified productions will be selected by the jury specially formed by the Organiser. The pre-selection results will be made available at [www.grandpik.pl](http://www.grandpik.pl) no later than 15<sup>th</sup> August 2015.
    - f) The verdict of the Grand PiK Competition jury will be announced at a gala in Artus Court in Toruń on 10.09.2015.
  10. The jury members are chosen by the competition Organiser.
  11. The First Prize in the competition is GRAND PiK. The financial value of the first prize is 15.000,00 PLN gross (fifteen thousand PLN). The Jury has the right to renounce awarding the first prize. Apart from the first prize the jury has the right to give special awards.
  12. Additional awards, apart from the first prize and special awards are: workshops participants' award, listeners' award (Terms and Conditions of the competition are available at [www.grandpik.pl](http://www.grandpik.pl)).
  13. The laureates are obliged to pay the tax from the value of the awards in the amount and in accordance with the regulations of the respective law especially by the regulations of the Personal Income Tax Act.
